This program is specially designed for Women Food Handlers working in organized/unorganized sector only.

#### The salient features of the Program: -

#### Eligibility Criteria for Candidates:

1. Only Women Candidates

#### Documents to be collected for each candidate:

- 1. Aadhar Card (other contact details required for SID and Fostac registration)
- 2. Registration Form
- 3. Pre-Screening Form

#### Terms and Conditions for Project Execution:

- 1. The Training Providers will have to mobilize the right candidates (women only) from
  - a. Food Processing Industries
  - b. SHGs working for food processing or packaged food segments
  - c. Local food handlers
- 2. Pre –screening test forms are to be captured for each participant
- 3. Employee data collection (Registration Form, Aadhar and all details required for SID and Fostac portal registration)
- 4. Batches should be created on both SIP and FoSTaC portal
- 5. Trainers should be certified by FICSI as well as FoSTaC
- 6. Batch wise Attendance Sheets of the candidates with the name of the Nominating Body
- 7. Batch wise Theory, Practical and group pictures and videos (Geotagged and Time-stamped)





- 8. After completion of the training, the candidates will be assessed and certified. certification will be provided to the successful candidates (dual certification).
- 9. Inauguration ceremony to be done before starting a batch in a particular district
- 10. Branding should be done at all Camps and Design/Artwork will be provided by FICSI
- 11. Certificate distribution ceremony to be done after successful certificate distribution
- 12. Social media updates and newspaper clippings to be captured
- 13. Weekly and monthly performance report to be submitted without fail
- 14. Participant Handbook will be provided by FICSI for all the participants
- 15. Impact Assessment Study will be done at the end of the Project
- 16. Deadline to complete the Training/Assessment is 1 month from the date of WO Allocation.
- 17. Targets will be allocated only to the FICSI affiliated Training Providers.
